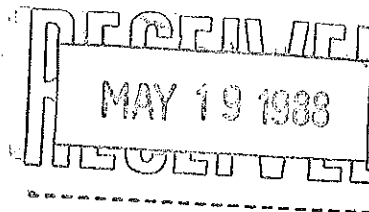



ARTICLES OF INCORPORATION

FOR

National Agricultural Aviation Association

TO: Department of Consumer and Regulatory Affairs
Corporate Division
Washington, D.C. 20001

We, the undersigned persons of the age of twenty-one years or more, acting as incorporators of a corporation under the NON-PROFIT CORPORATION ACT (D.C. Code, 1981 edition, Title 29, Chapter 5), adopt the following Articles of Incorporation:

ARTICLE I. NAME OF CORPORATION

The name of this organization shall be the National Agricultural Aviation Association.

ARTICLE II. DURATION

The corporation is to have perpetual existence.

ARTICLE III. PURPOSES

The purposes of NAAA shall be to coordinate and generally direct the efforts of the agricultural aviation industry on a national basis, at the national level, representing the entire industry and related interests, and for the mutual benefits derived therefrom for all its members.

ARTICLE IV. MEMBERSHIP

The corporation shall have members.

ARTICLE V. MEMBERSHIP

The corporation is to be divided into four (4) classes of members. There shall be sufficient membership classifications to assure full and complete participation in NAAA by all branches of the industry and of related industries. There shall be according to,

but not limited by, those various classifications enumerated below whose members' responsibilities, duties, rights, and privileges shall be governed by the Board of Directors as set forth in the Bylaws.

1. ORGANIZATION MEMBERS. State and regional associations composed primarily of agricultural aviators and agricultural aviation branches or divisions of state trade associations and/or other state, regional, or national associations. Members of such organizations shall be known as INDIVIDUAL members of NAAA with all the rights and privileges appertaining thereto in consideration of the satisfactory completion of the requirements for membership as set forth in the Bylaws.
2. PARTICIPATING MEMBERS. Any individual or firm engaged in agricultural aviation wishing to become associated with NAAA on an individually participating basis. Such members shall be known as PARTICIPATING members of NAAA with all the rights and privileges appertaining thereto in consideration of the satisfactory completion of the requirements for membership as set forth in the Bylaws.
3. ALLIED INDUSTRY MEMBERS. Industrial organizations and firms not engaged in agricultural aviation but closely allied to the agricultural aviation industry, such as, but not necessarily limited to aircraft manufacturers, aircraft engine manufacturers, systems suppliers, fuel companies, insurance underwriters, and other industries which serve the agricultural aviation industry shall be known as ALLIED INDUSTRY members of NAAA with all rights and privileges appertaining thereto in consideration of the satisfactory completion of the requirements for membership as set forth in the Bylaws.
4. HONORARY MEMBERS. Any person who, by unselfish devotion to furthering the interests and efforts of agricultural aviation nationally, has contributed to the welfare and growth of the industry to such an extent as to make that person's contribution outstanding and above the normal fulfillment of his professional or occupational duties and responsibilities.

ARTICLE VI. OFFICERS AND DIRECTORS

The manner of election or appointment of the directors of the corporation shall be provided in the Bylaws of the corporation.

ARTICLE VII. REGULATION OF INTERNAL AFFAIRS

1. The governing of NAAA shall be vested in a Board of Directors with control over the policy and internal management of the association, and whose responsibility it shall be to guide the efforts of the organization with the help and guidance of the national officers and qualified personnel as noted elsewhere in this Constitution and Bylaws.

2. Upon dissolution and liquidation of the corporation and after payment of any provision for liabilities and claims of the corporation, the directors of the corporation shall convey any remaining assets and income to such organization or organizations exempt under Section 501(c)(3) of the Internal Revenue Code of 1954, as the directors may select.

ARTICLE VIII. ADDRESS AND AGENT'S NAME
